The Subject acknowledges that, except as stated above, no additional compensation, royalties, or fees shall be owed for any use of the Materials.

5. Release of Claims

The Subject hereby releases and discharges the Organization, its officers, directors, employees, agents, and affiliates from any and all claims, demands, causes of action, and liability arising out of or in connection with the use of the Materials, including but not limited to claims for invasion of privacy, defamation, right of publicity, or copyright infringement.

6. Ownership

The Subject acknowledges that the Organization owns all rights, title, and interest in and to the Materials, including any intellectual property rights therein. The Subject waives any right to inspect, approve, or receive compensation for the finished product or its use.

This Release shall be governed by and construed in accordance with the laws of State of Delaware.
